2.	Stewardship runs a Donor Advised Fund, which is a type of charitable giving vehicle which makes it tax-effective and easy to give. As such, all funds Gifted by you into a Stewardship Giving Account are Stewardship's and become part of our charitable funds. You will have online access to your Giving Account and from there you can make requests to make Donations to Recipients. Funds that have been Gifted to Stewardship are irrevocable, outright Gifts from you to us and cannot be returned to you. All Donations paid from your Giving Account to Recipients are made at the discretion of Stewardship's trustees. Stewardship reserves the right to not make a Grant to a particular Recipient. These situations are rare but as a Christian charity an example would be that we cannot give to a charity advancing another faith.
